RAW LAND TRAIL EASEMENT

We, CBMR Real Estate, LLC, a Colorado limited liability company, having its principal place of business at P.O. Box A, Crested Butte, County of Gunnison, State of Colorado, for and in consideration of One and No/100 Dollar (\$1.00), the receipt of which is hereby acknowledged, do hereby grant to the United States of America, a non-exclusive non-motorized easement for a trail for use for all lawful purposes by the United States and its assigns, including but not limited to contractors, licensees, permittees, and the general public when authorized by the Grantee, over and across the parcels of land in the County of Gunnison, State of Colorado, described as follows:

T. 13 S., R. 86 W., Sixth P.M.

sec. 24: a fifteen (15) foot wide strip of land situated in the NW1/4, being more particularly described on Exhibit A, attached hereto and made a part hereof.

The said easement hereby granted is for the construction, reconstruction, maintenance, and full, free and quiet use and enjoyment of a trail as it shall be located and constructed over and across the above described premises as more particularly described by Exhibit A, titled "LEGAL DESCRIPTION, 15' WIDE TRAIL EASEMENT," attached hereto and made a part hereof.

The intent of this deed is to convey an easement as it shall be constructed across the above described premises, as would be disclosed by a proper survey and to exclude any portion of said trail not actually located within the Grantors's property lines.

The width of said easement shall be 15 feet, 7.5 feet on each side of the center line, or more if necessary to accommodate cuts and fills. The boundary lines of said easement shall be prolonged or shortened to begin and end on, and conform with, the Grantor's property lines.

Grantors reserve unto themselves, their successors and assigns the right to cross and recross the rights-of-way and trail by any reasonable means, and for any purpose in such manner as will not interfere with the Grantee's use of the trail.

If the Grantor desires to relocate the trail, or any segment thereof, it shall be at the Grantor's expense. The relocation shall not interrupt use of the trail herein granted to the United States of America and its assigns. Prior to any such relocation, the Grantor shall obtain written agreement from the Forest Service prior to any such relocation. Agreement by the Forest Service shall not be unreasonably withheld. If relocation occurs, Grantor shall subsequently grant to the United States of America an easement for the new location and Grantor shall construct the trail thereon having a standard equal to or better than the existing trail then the easement herein granted shall terminate. In the event the above described easement shall terminate as herein provided, the Regional Forester shall furnish the Grantor or their successors or assigns in interest, evidence of such termination as hereinafter provided.

The acquiring agency is the Forest Service, United States Department of Agriculture.

If the Regional Forester determines that the trail, or any segment thereof, is no longer needed, the easement traversed thereby shall terminate. The termination shall be evidenced by a statement in recordable form furnished by the Regional Forester to the Grantor or their successors, or assigns in interest.

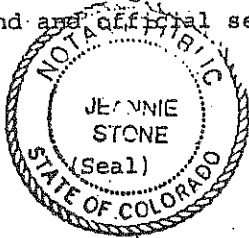
